END USER LICENSE AGREEMENT (EULA)



This is an agreement between You and Platformatics Inc. or its affiliates ("Platformatics") and governs your Use of Platformatics Software. "You" and "Your" means the individual or legal entity licensing the Software under this EULA. "Use" or "Using" means to download, install, activate, access or otherwise use the Software. "Software" means the Platformatics computer programs and any Upgrades made available to You by an Approved Source and licensed to You by Platformatics. "Documentation" is the Platformatics Deployment Guide, technical manuals, training materials, specifications or other documentation applicable to the Software and made available to You by an Approved Source. "Approved Source" means (i) Platformatics or (ii) the Platformatics authorized reseller, distributor or systems integrator from whom you acquired the Software. "Entitlement" means the license detail; including license metric, duration, and quantity provided in a product ID (PID) published on Platformatics' price list, claim certificate or right to use notification. "Upgrades" means all updates, upgrades, bug fixes, error corrections, enhancements and other modifications to the Software and backup copies thereof. "Source Code" means the human readable form of a software program, including all modules it contains, plus any associated interface definition files, scripts used to control compilation, and installation of an executable (object code).

This agreement, any supplemental license terms and any specific product terms at www.platformatics.com (collectively, the "EULA") govern Your Use of the Software.

1. ACCEPTANCE OF TERMS:

By Using the Software, You agree to be bound by the terms of the EULA. If you are entering into this EULA on behalf of an entity, you represent that you have authority to bind that entity. If you do not have such authority or you do not agree to the terms of the EULA, neither you nor the entity may Use the Software and it shall be returned to the Approved Source for a refund within thirty (30) days of the date you acquired the Software or Platformatics product. Your right to return and refund applies only if you are the original end user licensee of the Software.

2. LICENSE:

Subject to payment of the applicable fees and compliance with this EULA, Platformatics grants You a limited, non-exclusive and non-transferable license to Use object code versions of the Software and the Documentation solely for Your internal operations and in accordance with the Entitlement and the Documentation. Platformatics licenses You the right to Use only the Software You acquire from an Approved Source. Unless contrary to applicable law, You are not licensed to Use the Software on secondhand or refurbished Platformatics equipment not authorized by Platformatics, or on Platformatics equipment not purchased through an Approved Source. In the event that Platformatics requires You to register as an end user, Your license is valid only if the registration is complete and accurate. The Software may contain open source software, subject to separate license terms made available with the Platformatics Software or Documentation.

If the Software is licensed for a specified term, Your license is valid solely for the applicable term in the Entitlement. Your right to Use the Software begins on the date the Software is made available to You for Your Use and continues until the end of the specified term, unless otherwise terminated in accordance with this Agreement.

3. EVALUATION LICENSE:

If You license the Software or receive Platformatics product(s) for evaluation purposes or other limited, temporary use as authorized by Platformatics ("Evaluation Product"), Your Use of the Evaluation Product is only permitted for the period limited by the license key or otherwise stated by Platformatics in writing. If no evaluation period is identified by the license key or in writing, then the evaluation license is valid for thirty (30) days from the date the Software or Platformatics product is made available to You. You will be invoiced for the list price of the Evaluation Product if You fail to return or stop Using it by the end of the evaluation period. The Evaluation Product is licensed "AS-IS" without support or warranty of any kind, expressed or implied. Platformatics does not assume any liability arising from any use of the Evaluation Product. You may not publish any results of benchmark tests run on the Evaluation Product without first obtaining written approval from Platformatics.

4. FEEDBACK AND CONTRIBUTIONS:

"Feedback" means any feedback or suggestions that you provide to Platformatics regarding the Software or Platformatics product(s). If you provide Platformatics with any Feedback, Platformatics is free to use the Feedback however it chooses.

"Contribution" means any code, whether in Source Code format or object code format, or any other information or content, that you make available to Platformatics by any means. Mere use of code or content with the Software, without making that code or content available to Platformatics does not constitute a Contribution. If you make any Contribution available to Platformatics, you hereby assign to Platformatics all right, title, and interest (including all copyright, patent, and other intellectual property rights) in that Contribution for all current and future methods and forms of exploitation in any country. If any of those rights are not effectively assigned under applicable law, you hereby grant Platformatics a non-exclusive, fully-paid, irrevocable, transferable, sublicensable license to reproduce, distribute, publicly perform, publicly display, make, use, have made, sell, offer to sell, import, modify and make derivative works based on, and otherwise exploit that Contribution for all current and future methods and forms of exploitation in any country. If any of those rights may not be assigned or licensed under applicable law (such as moral and other personal rights), you hereby waive and agree not to assert all of those rights. However, you may continue to freely use any Feedback that you provide to Platformatics, and you may continue to use, in any manner consistent with the License, any Contribution that you make available to Platformatics.

You understand and agree that Platformatics is not required to make any use of any Feedback or Contribution that you provide. You agree that if Platformatics makes use of your Feedback or Contribution, Platformatics is not required to credit or compensate you for your contribution.

You represent and warrant that you have sufficient rights in any Feedback or Contribution that you provide to Platformatics to grant Platformatics and other affected parties the rights described above. This includes but is not limited to intellectual property rights and other proprietary or personal rights.

You authorize Platformatics to use and incorporate any feedback or ideas You provide Platformatics in connection with Your Use of the Software, whether as Evaluation Product or Software licensed to You by an Approved Source, and expressly acknowledge and agree that Platformatics has sole ownership over any such feedback or ideas.

5. OWNERSHIP:

Platformatics or its licensors retain ownership of all intellectual property rights in and to the Software, including copies, improvements, enhancements, derivative works and modifications thereof. Your rights to Use the Software are limited to those expressly granted by this EULA. No other rights with respect to the Software or any related intellectual property rights are granted or implied.

6. LIMITATIONS AND RESTRICTIONS:

You will not and will not allow a third party to:

- a. transfer, sublicense, or assign Your rights under this license to any other person or entity unless expressly authorized by Platformatics in writing;
- b. modify, adapt or create derivative works of the Software or Documentation:
- c. reverse engineer, decompile, decrypt, disassemble or otherwise attempt to derive the source code for the Software, except as provided in Section 17 below;
- d. make the functionality of the Software available to third parties, whether as an application service provider, or on a rental, service bureau, cloud service, hosted service, or other similar basis unless expressly authorized by Platformatics in writing;
- e. use Software that is licensed for a specific device, whether physical or virtual, on another device, unless expressly authorized by Platformatics in writing; or
- f. remove, modify, or conceal any product identification, copyright, proprietary, intellectual property notices or other marks on or within the Software;

7. THIRD PARTY USE OF SOFTWARE:

You may permit a third party to Use the Software licensed to You under this EULA if such Use is solely (i) on Your behalf, (ii) for Your internal operations, and (iii) in compliance with this EULA. You agree that you are liable for any breach of this EULA by that third party.

8. LIMITED WARRANTY AND DISCLAIMER:

- a. Limited Warranty: Platformatics warrants that the Software will substantially conform to the applicable Documentation for the longer of (i) Twelve (12) months following the date the Software is made available to You for your Use or (ii) as otherwise set forth at www. platformatics.com. This warranty does not apply if the Software, Platformatics product or any other equipment upon which the Software is authorized to be used: (i) has been altered, except by Platformatics or its authorized representative, (ii) has not been installed, operated, repaired, or maintained in accordance with instructions supplied by Platformatics, (iii) has been subjected to abnormal physical or electrical stress, abnormal environmental conditions, misuse, negligence, or accident; (iv) is licensed for beta, evaluation, testing or demonstration purposes or other circumstances for which the Approved Source does not receive a payment of a purchase price or license fee; or (v) has not been provided by an Approved Source. Platformatics will use commercially reasonable efforts to deliver to You Software free from any viruses, programs, or programming devices designed to modify, delete, damage or disable the Software or Your data.
- b. Exclusive Remedy: At Platformatics' option and expense, Platformatics shall repair, replace, or cause the refund of the license fees paid for the non-conforming Software. This remedy is conditioned on You reporting the non-conformance in writing to Your Approved Source within the warranty period. The Approved Source may ask You to return the Software, the Platformatics product, and/ or Documentation as a condition of this remedy. This Section is Your exclusive remedy herein.

c. Disclaimer: Except as expressly set forth above, Platformatics and its licensors provide Software "as is" and expressly disclaim all warranties, conditions or other terms, whether express, implied or statutory, including without limitation, warranties, conditions or other terms regarding merchantability, fitness for a particular purpose, design, condition, capacity, performance, title, and non-infringement. Platformatics does not warrant that the Software will operate uninterrupted or error-free or that all errors will be corrected. In addition, Platformatics does not warrant that the Software or any equipment, system or network on which the Software is used will be free of vulnerability to intrusion or attack.

9. LIMITATIONS AND EXCLUSIONS OF LIABILITY:

IN NO EVENT WILL PLATFORMATICS OR ITS LICENSORS BE LIABLE FOR THE FOLLOWING, REGARDLESS OF THE THEORY OF LIABILITY OR WHETHER ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE OR OTHERWISE, EVEN IF A PARTY BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES: (A) INDIRECT, INCIDENTAL, EXEMPLARY, SPECIAL OR CONSEQUENTIAL DAMAGES; (B) LOSS OR CORRUPTION OF DATA OR INTERRUPTED OR LOSS OF BUSINESS; OR (C) LOSS OF REVENUE, PROFITS, GOODWILL OR ANTICIPATED SALES OR SAVINGS. ALL LIABILITY OF PLATFORMATICS, ITS AFFILIATES, OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, SUPPLIERS AND LICENSORS COLLECTIVELY, TO YOU, WHETHER BASED IN WARRANTY, CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE, SHALL NOT EXCEED THE LICENSE FEES PAID BY YOU TO ANY APPROVED SOURCE FOR THE SOFTWARE THAT GAVE RISE TO THE CLAIM. THIS LIMITATION OF LIABILITY FOR SOFTWARE IS CUMULATIVE AND NOT PER INCIDENT. NOTHING IN THIS AGREEMENT LIMITS OR EXCLUDES ANY LIABILITY THAT CANNOT BE LIMITED OR EXCLUDED UNDER APPLICABLE LAW.

10. INDEMNITY:

You agree to indemnify, pay the defense costs of, and hold Platformatics, its licensors and their affiliates, its employees, officers, directors, agents, contractors, and other representatives harmless from all claims, demands, actions, losses, liabilities, and expenses (including attorneys' fees, costs, and expert witnesses' fees) that arise from or in connection with (a) any claim that, if true, would constitute a breach by you of this Agreement (including, without limitation, any Distribution or sublicensing of the Licensed Technology in violation of this Agreement) or negligence by you, (b) any claim brought by any third party to whom you Distribute or sublicense the Licensed Technology in violation of this Agreement (including without limitation any claim that the Licensed Technology infringes a patent), (c) any claim that any product or any other matter you created, or your exercise of the Software, infringes any third party's intellectual property rights or other proprietary or personal rights (except to the extent of any claim that your authorized use of unmodified Source Code or Software originally provided to you by Platformatics under this Agreement infringes any United States patent, trademark or copyright), or (d) any federal, state, or foreign civil or criminal actions related to any Software or Document. You agree to reimburse Platformatics on demand for any defense costs incurred by Platformatics and any payments made or loss suffered by Platformatics, whether in a court judgment or settlement, based on any matter covered by this Section 10.

If you are prohibited by law from entering into the indemnification obligation above, then you assume, to the extent permitted by law, all liability for all claims, demands, actions, losses, liabilities, and expenses (including attorneys' fees, costs and expert witnesses' fees) that are the stated subject matter of the indemnification obligation above.



11. UPGRADES AND ADDITIONAL COPIES OF SOFTWARE:

Notwithstanding any other provision of this EULA, You are not permitted to Use Upgrades unless You, at the time of acquiring such Upgrade:

- a. already hold a valid license to the original version of the Software, are in compliance with such license, and have paid the applicable fee for the Upgrade; and
- b. limit Your Use of Upgrades or copies to Use on devices You own or lease; and
- unless otherwise provided in the Documentation, make and Use additional copies solely for backup purposes, where backup is limited to archiving for restoration purposes.

12. AUDIT:

During the license term for the Software and for a period of three (3) years after its expiration or termination, You will take reasonable steps to maintain complete and accurate records of Your use of the Software sufficient to verify compliance with this EULA. No more than once per twelve (12) month period, You will allow Platformatics and its auditors the right to examine such records and any applicable books, systems (including Platformatics product(s) or other equipment), and accounts, upon reasonable advanced notice, during Your normal business hours. If the audit discloses failure to comply with this EULA, Your use of the Software will be terminated and You will pay the reasonable cost of the audit within thirty (30) days of receipt of written notice.

13. TERM AND TERMINATION:

This EULA shall remain effective until terminated or until the expiration of the applicable license term. You may terminate the EULA at any time by ceasing use of or destroying all copies of Software. This EULA will immediately terminate if You breach its terms, or if You fail to pay any portion of the applicable license fees and You fail to cure that payment breach within thirty (30) days of notice. Upon termination of this EULA, You shall destroy all copies of Software in Your possession or control.

14. TRANSFERABILITY

You may not transfer or assign these license rights to another person or entity. Any attempted transfer or, assignment not in compliance with the foregoing shall be void and of no effect.

15. US GOVERNMENT END USERS:

The Software and Documentation are "commercial items," as defined at Federal Acquisition Regulation ("FAR") (48 C.F.R.) 2.101, consisting of "commercial computer software" and "commercial computer software documentation" as such terms are used in FAR 12.212. Consistent with FAR 12.211 (Technical Data) and FAR 12.212 (Computer Software) and Defense Federal Acquisition Regulation Supplement ("DFAR") 227.7202-1 through 227.7202-4, and notwithstanding any other FAR or other contractual clause to the contrary in any agreement into which this EULA may be incorporated, Government end users will acquire the Software and Documentation with only those rights set forth in this EULA. Any license provisions that are inconsistent with federal procurement regulations are not enforceable against the U.S. Government.

16. EXPORT:

Platformatics Software, products, technology and services are subject to local and extraterritorial export control laws and regulations. You and Platformatics each will comply with such laws and regulations governing use, export, re-export, and transfer of Software, products and technology and will obtain all required local and extraterritorial authorizations, permits or licenses.

17 SURVIVAL:

Sections 5, 6, the warranty limitation in 8(a), 8(b) 8(c), 9, 12, 13, 15, 16, 17, 19 and 20 shall survive termination or expiration of this EULA.

18. INTEROPERABILITY:

To the extent required by applicable law, Platformatics shall provide You with the interface information needed to achieve interoperability between the Software and another independently created program. Platformatics will provide this interface information at Your written request after you pay Platformatics' licensing fees (if any). You will keep this information in strict confidence and strictly follow any applicable terms and conditions upon which Platformatics makes such information available.

19. GOVERNING LAW, JURISDICTION AND VENUE:

You agree that this Agreement will be deemed to have been made and executed in the State of Missouri, U.S.A., and any dispute will be resolved in accordance with the laws of Missouri, excluding that body of law related to choice of laws, and of the United States of America. Any action or proceeding brought to enforce the terms of this Agreement or to adjudicate any dispute must be brought in the Circuit Court of Jasper County or the United States District Court for the Southern District of Missouri. You agree to the exclusive jurisdiction and venue of these courts. You waive any claim of inconvenient forum and any right to a jury trial. The Convention on Contracts for the International Sale of Goods will not apply. Any law or regulation which provides that the language of a contract shall be construed against the drafter will not apply to this Agreement.

20. INTEGRATION:

If any portion of this EULA is found to be void or unenforceable, the remaining provisions of the EULA shall remain in full force and effect. Except as expressly stated or as expressly amended in a signed agreement, the EULA constitutes the entire agreement between the parties with respect to the license of the Software and supersedes any conflicting or additional terms contained in any purchase order or elsewhere, all of which terms are excluded. The parties agree that the English version of the EULA will govern in the event of a conflict between it and any version translated into another language.

21. AMENDMENTS OF THIS AGREEMENT:

Platformatics may issue an amended Agreement at any time in its discretion by providing notice to you or by providing you with digital access to the amended Agreement when you next log in to the Software or install additional content or Upgrades. You are not required to accept the amended Agreement. However, in order to continue accessing your account or the Software or to install or use additional Content or Upgrades, you must accept the amended Agreement. By logging in to your account, using the Software, or installing or using additional content or an Upgrade, you hereby agree to be bound by the amended Agreement then most recently issued by Platformatics. If you do not accept the amended Agreement, you may not log in to your account, access the Software, install or use additional content, or install or use any Upgrade that is made available by Platformatics contemporaneously with or after the issuance of that amended Agreement (but this will not terminate your License for the Licensed Technology that you installed prior to the issuance of the amended Agreement). If you are a legal entity, acceptance of an amended Agreement by any of your Users will be binding on you.
